Auro Pharma Inc is voluntarily recalling 7 LOTs of AURO-LOSARTAN (25mg, 50mg and 100mg) Tablets due to the presence of impurity (5-(4' - ((5 - (Azidomethyl) - 2-butyl-4-chloro-1H-imidazol-1-yl) methyl)-[1,1' - biphenyl] - 2-yl) - 1H-tetrazole above the acceptable concentration limit in affected lots. Auro Pharma has notified Health Canada about this recall.
